## Section 6. Accidental release measures

### Environmental precautions

### Methods and material for containment and cleaning up

#### **Small spill**

Stop leak if without risk. Move containers from spill area. Absorb with an inert material and place in an appropriate waste disposal container. Dispose of via a licensed waste disposal contractor.

#### **Large spill**

Stop leak if without risk. Move containers from spill area. Prevent entry into sewers, water courses, basements or confined areas. #### **Protective measures**

#### **Conditions for safe storage, including any incompatibilities**
